ANNOUNCEMENT

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of the Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

The board of directors of SIM Technology Group Limited (“**Company**”, together with its subsidiaries, “**Group**”) hereby announces that the unaudited monthly revenue of the Group was as follows:

1. Comparison of revenue with last month

The Group’s business is substantially based in the PRC. Since mid-March 2022 and until mid-May 2022, mandatory restrictions have been imposed in parts of the PRC to combat the coronavirus disease (COVID-19) pandemic. The revenue from core business in July 2022 was comparatively more than that in June 2022 as closed-loop production has only been resumed and implemented successively in parts of Shanghai since mid-May 2022 and some deliveries that should have been made in the first half of 2022 were delayed to July 2022. The revenue from non-core business predominantly comprised of rental income. The revenue from

non-core business in July 2022 was roughly the same as that in June 2022.

2. Comparison of revenue from core business with same month last year

The Group's business is substantially based in the PRC. Although the Group's deliveries have been affected by the mandatory restrictions imposed in parts of the PRC to combat the coronavirus disease (COVID-19) pandemic since mid-March 2022, closed-loop production has been resumed and implemented successively in parts of Shanghai since mid-May 2022. In addition, some deliveries that should have been made in the first half of 2022 were delayed to July 2022. Therefore, the revenue from core business in July 2022 increased as compared with the same period last year.

3. Comparison of total unaudited revenue of the Group for the seven months ended 31 July 2022 with same period last year

The Group's business is substantially based in the PRC. The Group's deliveries have been affected by the mandatory restrictions imposed in parts of the PRC to combat the coronavirus disease (COVID-19) pandemic since mid-March 2022. Therefore, the total unaudited revenue of the Group for the seven months ended 31 July 2022 decreased significantly as compared with the same period last year.

The core business of the Group comprises (i) the ODM (original design manufacturer) of handsets and IOT terminals and (ii) the EMS (electronic manufacturing services) business and the non-core business of the Group comprises properties management.

The above information is extracted from the management accounts of the Group, which have not been reviewed or audited by the auditors of the Company.
